- Joint Labour Commissioner (Senior most) in the Directorate of Labour Commissioner.
- Assistant/Deputy/Joint Labour Commissioner dealing with the Child Labour subject. in the Directorate of Labour Commissioner.
- Under Secretary dealing with Child Labour in the Secretariat.

The Cell will work under the overall guidance and direction of the Commissioner-cum-Secretary, Labour & Employment Department and assist in monitoring the implementation of the directions dt. 10.12.1996 of the Hon'ble Supreme Court of India, in Writ Petition (Civil) No. 465/86. M.C. Mehta Vs. State of Tamil Nadu and others and all matters connected with the abolition of Child Labour, their education, rehabilitation and the matter relating to constitution of a Welfare fund will also be dealt with in the Cell.

The Cell shall start functioning with immediate effect in the Directorate to perform the duties and discharge the functions as have been recommended by the Special Rapporteur to N.H.R.C. in his report from 05.12.2007 to 07.12.2007 and Government orders in the matter as would be issued from time to time

In pursuant to this Department 0.0.No.6723/LF dt-18.6.08. the reconstituted State Child Labour Cell is hereby assigned the following duties and responsibilities :-

- 1. The Cell should meet twice a month to monitor and implement identification of Child Labour, their release rehabilitation and abelition and all matters relating to constitution and working of Welfare fund.
- 2. The cell should monitor and implement directions of Hon ble High Court/Supreme Court from time to time.
- 3. The Joint Labour Commissioner in charge of the State Child Labour Cell should visit one NCLP District fortnightly, and ensure enforcement of all activities in NCLP Special Schools in the districts.
- 4. The Joint Labour Commissioner in the State Child Labour Coll will review receipt and expenditure of funds alloted by Government of India to NCLP Schools during field visit.
- 5. The Joint Labour Commissioner in the State Child Labour Cell will attend to all compliance of National Human Rights Commission.
- 6. The Joint Labour Commissioner in the State Child Labour Cell will also attend to all questions relating to Lok Sabha, Rajya Sabha and State Legislative Assembly relating to Child Labour.
- 7. Any other assignment of duties and responsibilities to be given/required by the Government/Labour Commissioner, Orissa in connection with Child Labour and allied subject.
